The Truvista Fiber Class of 2026 Graduation Giveaway Presented by the Uninterrupted Summer Campaign ("Giveaway") is sponsored by Truvista Fiber, a service of Truvista Communications, Inc. ("Truvista," "Sponsor," "Company," "we," "our," or "us").

By participating in the Giveaway, entrants agree to be bound by these Official Rules and the decisions of Truvista, which are final and binding in all matters relating to the Giveaway.

2. Eligibility

The Giveaway is open only to graduating members of the Class of 2026 residing within eligible Truvista Fiber residential service areas in South Carolina and Georgia.

To be eligible:

- The entrant must be a graduating member of the High School Class of 2026.
- The entrant, or the entrant's parent/legal guardian, must be a current Truvista Fiber residential customer in good standing at the time of entry and prize fulfillment.
- The graduating student must reside at the service address associated with the qualifying Truvista Fiber account.

- The entrant must provide proof of graduation upon request.

Participants Age 18 and Older

Graduates who are eighteen (18) years of age or older may enter directly.

Participants Under Age 18

Graduates under eighteen (18) years of age may enter only with the permission and consent of a parent or legal guardian.

For entrants under age 18:

- The parent or legal guardian must be the Truvista Fiber account holder or reside in the same household as the account holder.
- The parent or legal guardian must be a current customer in good standing.
- The graduating student must reside in the same household.
- The parent or legal guardian may submit the entry on behalf of the student or authorize the student to submit the entry.

By allowing a minor to participate, the parent or legal guardian acknowledges and agrees to these Official Rules.

Employees, officers, directors, contractors, agents, affiliates, subsidiaries, advertising agencies, and immediate family members or household members of Truvista Communications, Inc. are not eligible.

3. Giveaway Period

The Giveaway begins at 12:00 a.m. Eastern Time on June 1, 2026 and ends at 11:59 p.m. Eastern Time on June 30, 2026 ("Giveaway Period").

Entries received outside the Giveaway Period will not be considered.

The Sponsor's computer systems and records shall serve as the official timekeeping devices for the Giveaway.

4. How to Enter



To enter, eligible participants must:

- Be a current Truvista Fiber residential customer or reside in a household with a qualifying Truvista Fiber customer.
- Complete the official entry form.
- Submit any required graduation information and supporting documentation.
- Complete all instructions identified in the official Giveaway announcement.

Limit one (1) entry per household and per Truvista account.

Multiple entries from the same household may be disqualified.

Incomplete, inaccurate, fraudulent, or misleading entries may be disqualified.

The use of automated systems, bots, scripts, artificial intelligence tools designed to mass-enter, vote exchanges, or other manipulation methods is prohibited.

5. Prize Details

Three (3) winners will be selected.

Prize 1

Six (6) months of \$50 monthly bill credits.

Prize 2

Free Truvista Stream service for one (1) year.

Prize 3

2 Gig Fiber Internet service for the price of 1 Gig Fiber Internet service for one (1) year.

Approximate retail value varies based on service location, package eligibility, and market pricing.

Prizes are non-transferable and may not be redeemed for cash.

6. Prize Conditions

\$50 Monthly Bill Credit Prize

- Applied over six (6) consecutive billing cycles.
- Monthly recurring service charges must equal or exceed the promotional credit amount before taxes and fees.
- Credits apply only to qualifying recurring monthly service charges.
- Credits may not be applied to taxes, installation fees, equipment charges, late fees, prior balances, or non-recurring charges.
- Credits have no cash value.

Truvista Stream Prize

- Available only where Truvista Stream service is offered.
- Compatible internet service and streaming equipment may be required.
- Premium channels, add-on services, pay-per-view purchases, third-party subscriptions, taxes, and fees are not included.
- Customer account must remain active and in good standing throughout the promotional period.

2 Gig for the Price of 1 Gig Prize

- Available only in qualifying fiber service areas.
- DSL and coax customers are not eligible unless upgraded to qualifying fiber service.
- Customer must meet serviceability requirements.
- Customer must have compatible equipment.
- Installation, equipment, and upgrade charges may apply.
- Promotional pricing remains valid only while maintaining qualifying Truvista Fiber service.

7. Winner Selection

Three (3) winners will be selected by random drawing from all eligible entries received during the Giveaway Period.

The drawing will be conducted by Truvista or its designated representative.

The odds of winning depend upon the number of eligible entries received.

8. Winner Notification

Potential winners will be contacted using the contact information provided during entry.

If a selected winner:

- Cannot be contacted,
- Fails to respond within seven (7) calendar days,
- Fails to provide required documentation,
- Refuses the prize,
- Is no longer a customer in good standing,
- Is determined to be ineligible,

Truvista reserves the right to disqualify the entrant and select an alternate winner.

9. Winner Verification

Before receiving a prize, winners may be required to provide:

- Proof of parental or guardian consent (if applicable)
